- (a) According to supplier when contacted regarding the assay results, overages were put in to maintain shelf life potency. No repeats were done even though the analysis of the sample did exceed his specification parameters.
- (b) Differs from Vagisil in color and odor as is and in use; lacks clean floral note. A total deduction of only -0.50 pts. was taken due to the nature of the product and its use.
